The Design Manager for Infrastructure will be reporting to the Planning, Design & Permitting Director.

Our new colleague in this position will be responsible for the development and management of the Infrastructure design in Hellinikon Project, from the pre planning to the detailed design stage. This includes **roadworks**, **earthworks**, **utilities**, **marine**, **underpasses**, **bridges etc design**.

He/she shall supervise and manage the design team and design consultants/advisors responsible for Infrastructures and will ensure that design fits the purpose and project objectives are indeed met, as defined in the Project Charter and Business plan. He/she will also participate, under the direct supervision of PDP Director, in the Hellinikon project permit process and shall ensure compliance.



In detail, the Design Manager for Infrastructure, will be responsible for the following aspects of the Hellinikon Project:

- **Master Planning:** Participates in the development of the Master Planning of Hellinikon Project and is responsible for the design of Infrastructures as these have been defined in the Master Plan. He/she also provides all relevant technical information, including drawings, calculations, submissions, and other technical documents upon the request of the Planning, Design & Permitting Director
- **Design Management:** Manages the design process of Infrastructures, and participates in the management of Design Consultants/Technical Advisors related with Infrastructures. He or she also provides the description of the scope of work for Design Consultants services and defines the applicable design specifications, codes, requirements and deliverables. Of course, this person also monitors the Design Consultant's performance and is responsible for the excellent information flow and communication with them. Ensures that the design information of Infrastructures is of the right quality and keeps pace with project time schedule
- **Design Review & Coordination:** Offers advice and recommendations to his/her immediate supervisor on design approvals, reviews design submittals and participates in the design co-ordination process by sharing information with the project team. Our new colleague also co-ordinates stakeholders (Specialist designers, End users, Authorities, Project and Construction Managers, Contractors) for the immediate resolution of any technical matters that may arise, at the design and construction stage. He or she also manages the design verification and validation from 3rd party for the Infrastructures. Finally, in this position, our colleague also participates in the approval of key project elements and sub-contractors, samples, mock-ups and quality benchmarks during the construction/ execution procedure
- **Participation in the Hellinikon Project Permit Process:** Participates in the Permitting process of Hellinikon project by ensuring that the Infrastructure designs meet legislation, standards and codes of practice where appropriate
