# In detail, the Senior Risk Engineer, will be responsible for the following aspects of the Hellinikon Project:

- **Risk Management Framework:** our new colleague in this role, will support the development, management and implementation of the Project's Risk Management Plan, Policies and Procedures. Additionally, he or she will focus on the development, management and administration of the relevant Risk Management Systems and work with the Risk Management team and external consultants
- **Risk Register:** In this role, the new coworker will have to develop, manage, update, report and issue the Project's Risk register; he or she will integrate the assigned Consultants, Project Managers and Contractors Project Risk Data, and of course, prepare data and participate in the risk management meetings
- **Risk Assurance:** he or she will be responsible for the assurance of all Risk data submitted by Consultants, PMs and Contractors, will provide adherence checking and reporting against agreed Risk KPIs
- **Reporting:** this position also entails the preparation and issue of Monthly/Quarterly/Annual Progress, as well as ad-hoc reports and presentations to our Executive Team and the Internal and External Stakeholders. The job holder will also be involved in the development of templates and dashboards related to Risk data, conduct "what-if" studies based on the Risk data & provide independent analyses, for proposed Project Revisions and Changes
- **Integration:** the ideal job holder will also need to be alert to any Risk changes/variations that may influence the Project's outcomes, support the development, management, updating, reporting and issuing of the Integrated Project Master Schedule and Baseline, run the Project QSRA (based on the Programme Master Schedule) and QCRA and report as required
