The Company is the Data Controller of your personal data, collected through the Website, pursuant to EU General Data Protection Regulation 679/2016 (hereinafter "GDPR") and L. 4624/2019. This Privacy Notice is provided in order to inform you on the personal data collected, to explain the way and purpose of data processing, to state any third parties with whom we share your data and finally to inform you on your rights.

What personal data do we process?

Personal data we collect and further process during your visit to the Website, are the following:

- Technical information, such as IP address, date and time of visit, type of browser and operating
 system, device model, and other information collected through cookies and similar technologies,
 which are relevant to the analysis of your visit to the Website. For more information regarding data

 the Group Career Opportunities: Home (successfactors.eu), the set of personal data you enter will
 be collected and processed, such as name and surname, email address and country/ region of
 residence.
- If you wish to contact the Investor Relations division of the Company, through the submission of the
 Investor Relations Contact Form, we collect personal data, such as name and surname, email,
 telephone number, company and profession.
- If you wish to submit namely a <u>Public Grievance Form</u>, we collect personal data, such as phone number, email address and language.

Why do we process your personal data?

Within the context of the Website's use, the Company processes your data according to the following purposes and legal bases:

A. Legitimate Interest

C. Contract

With whom do we share your personal data?

For the fulfillment of the aforementioned purposes, your data may be disclosed to third parties, such as:

- Social Media Coordinators and advertising companies.
- Other companies of the Group with which we collaborate for the fulfillment of the aforementioned purposes.

How does the Company protect your personal data?

How long we retain your personal data?

Your rights

You can exercise any of the abovementioned rights by submitting a written request to our Company. You can expect a reply to such a request within one (1) month following its receipt by the Company and in any case, within two (2) months, depending on the perplexity of your request or the high volume of requests received.

Furthermore, our Company is responsible for informing you, without undue delay, for any breach concerning your personal data, which may put in danger your rights and freedoms and under the condition that it doesn't fall under the exceptions provided in the law.
