

ANNOUNCEMENT FOR THE AVAILABILITY OF THE PROSPECTUS OF «LAMDA DEVELOPMENT S.A.»

The company «LAMDA Development S.A.» (hereinafter: "LAMDA" or "Company" or "Issuer") announces that as of 08.07.2020 it makes available to investors, the Prospectus, as approved by the meeting of Board of Directors of the Hellenic Capital Markets Commission dated 07.07.2020, which was drafted pursuant to the Regulation (EU) 2017/1129 and the delegated Regulations (EU) 2019/979 and 2019/980 and law 3401/2005, to the extent applicable after the entry into force of Regulation (EU) 2017/1129,and as in force, in relation to the issuance by the Company of a common bond loan (the "CBL"), of a total amount of up to \leq 320,000,000, of a duration of seven (7) years, divided into up to 320,000 dematerialized, common, bearer bonds, each of a nominal value of \leq 1,000 (the "Bonds"), in accordance with the resolution of the Company's Board of Directors dated 23.06.2020 (the "Issue"),. The Bonds that will be issued, will be offered for subscription by investors by means of a public offer (the "Public Offer"), with use of the electronic book-building service ("EBB") of Athens Exchange and will be admitted for trading in the category of Fixed Income Securities of the Organized Market of the Athens Exchange (the "Athens Exchange").

The Athens Exchange ascertained on 02.07.2020 that the relevant conditions for admission for trading in the category of Fixed Income Securities of the Organized Market of the Athens Exchange have been met in principle.
